

Participant Agreement & Waiver

By attending Spirit Vine, I acknowledge that I am entering a sacred, intentional, and communal healing environment. I understand that my participation requires personal responsibility, honesty, respect, and care—for myself, for others, and for the traditions that guide this work.

Please initial each section to confirm your understanding and agreement.

1. Personal Responsibility & Readiness

- I affirm that I am participating voluntarily and of my own free will.
- I understand that ayahuasca and other plant medicines are powerful and can bring emotional, psychological, and physical intensity.
- I take full responsibility for my experience, reactions, and integration before, during, and after the retreat.
- I understand that Spirit Vine does not guarantee specific outcomes or healing results.

2. Honesty, Health & Safety

- I confirm that all information I provided in my application—including medical history, mental health history, medications, supplements, and substance use—is accurate and complete.
- I understand that withholding information may endanger myself or others and may result in removal from the retreat without refund.
- I agree to follow all dietary, medication, and preparation guidelines as instructed by Spirit Vine.

3. Substances & Personal Items Policy

- I understand that for the safety of all participants, all items I bring onto the property—including snacks, medications, supplements, drugs, alcohol, or other substances—must be handed in upon arrival.
- I understand that approved and necessary medications will be managed by staff and returned as appropriate.
- I acknowledge that any unauthorized substances will be held until the end of the retreat and that refusal to comply may result in dismissal.

4. Ceremony Conduct & Group Respect

- I agree to follow all instructions given by facilitators, healers, and staff at all times.
- I understand the importance of silence, presence, and non-interference during ceremonies.
- I agree not to touch, assist, or intervene in another participant's process unless explicitly directed by staff.
- I commit to treating all staff, facilitators, healers, volunteers, the gardens/grounds, animals, and fellow participants with respect and kindness.

5. Confidentiality & Sacred Sharing

_____ I understand that what is shared in group circles and ceremonies is confidential.

_____ I agree not to repeat, record, share, or discuss other participants' stories, emotions, or experiences outside the retreat—verbally, online, or on social media.

_____ I commit to honoring each person's vulnerability without judgment, advice-giving, or comparison.

6. Cell Phone, Technology & Media Use

_____ I understand that Spirit Vine limits cell phone and technology use to support presence, safety, and integration.

_____ I agree to surrender my phone if requested and to use devices only at designated times or for emergencies.

_____ I agree not to take photos, videos, or audio recordings during ceremonies or group spaces unless explicitly permitted.

7. Boundaries, Relationships & Community Safety

_____ I agree to maintain clear personal and relational boundaries throughout the retreat.

_____ I understand that romantic or sexual interactions between participants during the retreat are not permitted.

_____ I acknowledge that violating boundaries or community agreements may result in my removal from the retreat.

8. Integration & Aftercare Responsibility

_____ I understand that integration is an essential part of this work and commit to caring for myself after the retreat.

_____ I acknowledge that Spirit Vine does not replace medical, psychiatric, or psychological care.

_____ I take responsibility for seeking additional support if challenges arise after the retreat.

Assumption of Risk & Waiver of Liability

I acknowledge that participation in ceremonies and retreat activities involves inherent risks, including emotional distress, physical discomfort, and psychological challenges. I voluntarily assume all risks associated with my participation.

I hereby release, waive, and hold harmless Spirit Vine Retreats, its founders, facilitators, healers, staff, volunteers, and affiliates from any liability, claims, or demands arising from my participation, except in cases of gross negligence or intentional misconduct.
